1. I, Daniel T. Goodwin, having been duly sworn do state and affirm as follows:
2. I am one of the attorneys for the Defendants in the above-captioned action.
3. I was the attorney responsible for preparing the responses to the motions filed by the Plaintiffs which the Court has denied.
4. I am a partner in this firm with the Firm's customary hourly rate for of \$350 per hour.
5. I have been assisted in this matter by Blaine D. Bowne, an associate attorney in this firm with the Firm's customary hourly rate of \$195 per hour.
6. I have been assisted in this matter by Carla Embry, a paralegal in this firm with the Firm's customary hourly rate of \$125 per hour.
7. I have been assisted in this matter by Janice Bennett, a legal assistant/paralegal in this firm with the Firm's customary hourly rate of \$115 per hour.


